## h) Functions of the Ombudsman under section 8

Article 156 of the Constitution of the Democratic Socialist Republic of Sri Lanka stipulates that the Parliament shall provide for the establishment of the Office of the Parliamentary Commissioner for Administration (Ombudsman) which position is charged with the duty of investigating and reporting upon complaints or allegations of the infringement of fundamental rights and other injustices by public officers and officers of public corporations, local authorities and other like institutions. Accordingly, provisions have been stipulated in terms of Parliamentary Commissioner for Administration Act, No.17 of 1981 as amended by the Act, No.26 of 1994. The main function of the Ombudsman is to investigate and submit recommendations upon complaints or allegations of the infringement of fundamental rights and other injustices by public officers which are directly made to the Ombudsman, by a communication in writing, addressed to the Ombudsman or on the petitions forwarded to the Committee on Public Petitions by a Member of Parliament through Hon.Speaker or petitions forwarded to the Commissioner by the Committee itself.
